24<sup>th</sup> November 2023 – Mumbai, 1<sup>st</sup> December 2023 – Delhi, 8<sup>th</sup> December - Kolkata (dates TBC)

<u>Festa Italiana</u> is the flagship event produced and organized by the IICCI to promote Italy's unique brands, know-how, and lifestyle in India. Festa Italiana 2023 will take place in prime locations in the three cities and will focus on:

- Fashion and accessories: with the organization of a fashion show and an exhibition of jewellery, eyewear, footwear, leather products by iconic Italian brands
- Food and wine: organization of corners with cooking demonstrations and wine tastings, within the frame of the Italian Cuisine Week in the World
- Furniture and design: exhibition of Italian furniture and design brands
- Automotive: exhibition of Italian sport cars and bikes

## Invest in Italy Summit

#### March 2024 – Delhi (date TBC)

For the first time, the IICCI in collaboration with the Embassy of Italy in Delhi and other Italian Institutions will provide the attendants with a platform to discuss the investment trends from India to Italy. The targets of the summit are:

- Indian companies that have already invested in Italy and prospect Indian investors,
- Professional firms and consultants engaged in assisting Indian companies for greenfield projects in Italy, and Indian and Italian companies for brownfield and M&As.

Its aim is to:

- Provide data and statistics on the current Indian investments into Italy,
- Access to existing investment opportunities in Italy
- Financial, fiscal, and administrative tools and incentives to facilitate Indian investments into Italy.

**Italian Tech in India** - Italian Know-How for India's Energy Transition and Manufacturing Growth Jan 2024 – Bangalore & Feb 2024 – Chennai (TBC)

After a <u>first successful edition</u> in March 2023 in the 2 cities of Delhi and Pune, this second edition of the exhibition will once again collect and display the brightest examples of Italian know-how present in India to highlight the contribution of the Italian technologies to the Indian economic and technological growth. Aim of the initiative is to:
