ITALIAN-INDIAN COLLABORATION FOR THE RECYCLING OF PET BOTTLES

Ganesha Ecopet, a division of the largest Indian PET recycler, Ganesha Group, entrusted SOREMA, the division of PREVIERO specialized in the construction of plastic recycling plants, with the realization of a PET bottle-to-bottle recycling plant in India.

It is a pioneering project, the first of its kind in the country, with a production capacity of 5,000 kg/hour of food-grade recycled PET material.

This process involves the 100% use of locally collected PET plastic post-consumer bottles, a SOREMA washing system, followed by an extrusion and solid stating Starlinger section.



The quality of the finished product gained approval from industry giants like Coke & PepsiCo, and others utilizing the produced rPET pellets for 100% rPET bottle manufacturing.

"Our goal is not just to recycle plastic but create viable options for green supply chain and circular economy solutions in India.
